THIS AMENDMENT TO DECLARATION OF CONDITIONS, RESERVATIONS AND RESTRICTIONS FOR COASTAL MEADOWS, SECTION I, (the "Amendment") is made this day of November, 2022, by E & J DEVELOPERS, LLC, a North Carolina limited liability company, hereinafter referred to as the "Declarant";

WHEREAS, Declarant has heretofore caused to be recorded a Declaration of Conditions, Reservations and Restrictions for Coastal Meadows, Section I in Book 1763, Page 125, in the Office of the Register of Deeds of Carteret County, North Carolina, as amended in Book 1781, Page 385, Carteret County Registry (collectively, the "Declaration");

WHEREAS, the Declarant has the right under Section XVIII, "Modifications" of the Declaration to amend the Declaration by virtue of its entitlement to at least sixty seven percent (67.0%) of the votes in the Association;

**NOW, THEREFORE**, the Declarant does hereby amend the Declaration by adding and inserting at the end of Article IV, Section 13, the following:.

1. Notwithstanding the foregoing, and subject to any governmental law, rule, ordinance or regulation, not more than five (5) chicken hens (but no roosters) may be kept on a lot for domestic purposes only, subject to the following restrictions and conditions: (a) the hens shall be continuously confined in a predator proof cage, coop, crate or other similar fully enclosed apparatus, (b) the cage, coop, crate or other fully enclosed apparatus must be situated in the rear of the primary dwelling so as to restrict it from being viewed from the street or streets adjacent to the lot as much as reasonably possible, (c) no coup shall be placed closer than 25 feet from the rear property line, nor closer than 10 feet to any side lot line, (d) chicken waste shall be disposed of in an expeditious manner so as not to transmit an offensive odor to

adjoining lots, and (e) the chickens shall not be maintained for any business or commercial use..

 INCORPORATION BY REFERENCE: All of the terms, covenants, conditions, restrictions, rights, duties and obligations as set forth in the Declaration, as heretofore amended, are hereby incorporated in this Amendment by reference.

**EXCEPT** as hereby amended, the conditions, covenants and restrictions set forth in the Declaration shall remain in full force and effect.
